Committee Reports

- Tournament Alan Hargreaves
 - La Quinta under contract.
 - I could not make Eugene work as a tournament venue. I then tried Salem. The new style Holiday Inn was very nice. And the Grand, downtown was a good location but banquet would be expensive (\$70). After Board discussion it was decided the Holiday Inn would be preferred.
 - Green Valley CC, tentatively scheduled for fall of 2020, is proving difficult to organize due to course maintenance on all the courses. We were only offered October 19 and 26. John suggested Green Valley in May, and Salem in September.
 - Alan thought Tahoe in July 2021 would be a good destination

 - Alan sent an email to past members and guests, showing upcoming schedule and opening the possibility of them rejoining. Alan did this and we had a couple of members rejoin. Alan has created a email list, with unsubscribe capabilities, and will use this to keep in contact with past members.
 - John had asked for a list of all the past members from Oregon. Alan sent this, together with Washington. Interesting that we currently have no members living in Oregon.
